- Capital value including unimproved and improved valuation
- A few details regarding the buildings, fencing, planting, permanent draining, clearing, grass or pasture and other improvements the value of some items

The section is listed in Valuation number order not alphabetical so can take some time to locate relative information regarding a section or person.

The opposite page has minimal information and records some 'Special Rating Districts' and 'Roll Alterations'.
