- 01 October 1928 from G S Phillips to Minister of Lands Your Department has had for some considerable time a Plan of a proposed Sub-division of a part of my Kaitoke property and as I am very anxious to be able to place the Sub-Division on the market this Summer I shall be very much obliged if the return of the Plan with your approval or otherwise is hastened as much as possible.
- 04 October 1928 from Chief Surveyor to Department of Lands and Survey Proposed Town of Rimutaka forward plan prepared on behalf of Mr H M Phillips by Mr C D Truebridge (referring to above)
- 11 October 1928 from Minister of Lands to Mr G S Phillips Town of Rimutaka I have to inform you that the scheme of subdivision of part of your property at Kaitoke (Section 18 Hutt District) has now been submitted to the Director of Town Planning for urgent consideration (2 copies)
- 19 October 1928 from Surveyor General to Chief Surveyor Proposed Town of Rimutaka returning plan in order that the question of a cross road may be looked into. It seems to me that Lot 5 is about the place where a road reserve should be provided to give access to the area behind the subdivision
- 15 October 1928 from Director of Town Planning to Surveyor General returning plans until further information is available (Proposed Town of Rimutaka)
- 26 October 1928 from Chief Surveyor to Surveyor General Proposed Town of Rimutaka in regard to the above named Town was referred to the Surveyor and a reserve for future road access has been provided in the locality mentioned. As the owner requires to deal with this land immediately I should be glad if you could give a provisional approval to the scheme in the event of the Minister being too busy at the present time to attend to it.
- 29 October 1928 from Surveyor General to Chief Surveyor Town of Rimutaka the approval of this scheme of subdivision may be anticipated if necessary for advertising purpose
