1921 Town of Silverstream Section 97 & 142 & 83

- PLAN of proposed Town of Silverstream Extension No 4 being part of Section 97 Hutt Registration District Block 1 Rimutaka Survey District Hutt County W G Gard owner – Pemysey Road – Terminus Road – Recreation Reserve – Wellington Napier Railway Chief Surveyor 23/12/1921 approved Minister of Lands 14/2/1922 (1921) saved 30/08/2017 as IMG_
- 23 December 1921 from Chief Surveyor to Surveyor General Town of Silverstream extension No 1 [sic] The land is owned by Mr Gard who was the owner of a considerable portion of the adjoining land most of which has been however disposed of. The purpose of the subdivision is residential. In order to provide a site for a library a small section equal to one chain square has been set aside out of what was originally section 1. The result of this is that the frontage to sections 1 and 6 are both under 40 feet being 33 feet each. As this cannot be avoided without recasting a portion of the scheme I recommend that the Minister should be asked to approve of these two frontages. The scheme in other respects complies with requirements and is in order for approval.
- 10 January 1922 from Surveyor General to Chief Surveyor Town of Silverstream extension No 4 (noting extension No 1 above should be extension 4) It is not in order as the original town scheme approved by the Governor in 1910 shows the Reserve (Section 82) now Terminus Road extending to the Railway Reserve. This now scheme therefore overlaps and amends a scheme already approved.
