Mary Street for goods to the amount of £5 18s which she ordered to be sent to Mrs L'Estrange of 29 Blessington Street. The order bore the lady's signature and appeared so genuine that the porter drove in the evening with the parcels, which were received by the accused. The porter was told by her that her mistress waited until the last moment to pay him for the parcels, and at length had to go to Kingstown but was to return at seven o'clock in the evening. When the porter went away the accused took a cab and absconded from the house without the knowledge of her mistress. On the following day she went to the establishment of Mr Pemberton 24 Mary Street and obtained two pairs of boots to fit herself stating it was at the order of the Rev Mr Collins of Blessington Street whose servant she represented herself to be. On yesterday the detectives succeeded in tracing the prisoner to 26 South Cumberland Street where they recovered the greater portion of the missing property. She was sent for trial to the City Sessions.

By the 1820s and 1830s the appearance of many Irish towns had been improved by the building of smart little town-houses, often in terraces, and suitable for the nascent middle class. A universal feature of such houses was a handsome doorway with a leaded fanlight. Pages 206 and 207 show a selection of these. The houses in the Mall, Waterford, are important ones, provincial rivals of Merrion Square. Charlemont Place is a terrace of superior houses in the Mall at Armagh, built of local limestone ashlar and having wrought-iron balconies. The low two-storey house at Cloghan, Co Offaly, which belonged to the Lestrange family, is much simpler, its only pretension to refinement being the doorway.

The mystery of Margaret Lestrange

In 1874 the three ships that left Queenstown, Cork, Ireland for NZ were organised by Caroline Cadette Howard (1821-1907).

- [1] Asia (NZ Shipping Co.) departed London & Cork 07 Feb 1874 and arrived Otago 27 Apr 1874
- [2] Caroline (NZ Shipping Co.) departed Queenstown 14 Apr 1874 & arrived Otago 14 Apr 1874
- [3] Carrick Castle (Shaw Saville) departed Queenstown 27 Apr 1874 & arrived Bluff 14 Jul 1874

Except for two people from India (Caroline) the latter two ships contained only Irish immigrants.

The 16 people from Westmeath, Ireland all arrived on the <u>Asia</u> – farm labourers John Cleary (17yrs), <u>Christopher Lestrange</u> (18), Michael Maloney (30), Michael Nulty (28), William Thornton (18) and James Mulligan (21); servant Kate Mulligan (25); unspecified Peter Boyhan (27) and Mary Boyhan (23) and the seven members of the Irwin family – William (43) General Labourer, his wife Anne (39) and children Mary Ann (17), Anne (14), Charles (9), Hubert (3) and Deliah (1)

Of the 904 Irish passengers recorded for the three ships only two were from Dublin

- [1] Ellen Long (18) General Servant on the Caroline
- [2] Margaret Lestrange (24) Cook on the Carrick Castle

In 1873 Dr Edward L'Estrange, a ship's surgeon, died of fever on the ship 'Glenlora' on its way to Wellington via Mauritius. He was 41 years of age. The 'Glenlora' left London 07 Aug 1872 and arrived at Wellington 11 Mar 1873 – a voyage of 215 days. His relatives were allowed £50 which was half of what he would have received if he had survived the voyage. The ship carried assisted immigrants equivalent to 60 statute adults. There is a baptism for an Edward Lestrange on 30 Jun 1833 at St Andrews in Dublin – parents Edward/Julia and two witnesses – Ellen Doyle and another that cannot be read.

Is it a coincidence that both Margaret and Christopher Lestrange lived in the Invercargill area after their arrival? Perhaps they were drawn there by Louis Hume (1829-1907) the son of Charles Augustus Hume (1799-1870) and his wife Maria nee Lestrange (1791-1863). Louis Hume first appears in the Otago Daily Times of 08 June 1863 in a list of unclaimed letters for the month ending 30th April 1863. In the Southland Times of 11 Sep 1863 he advertised for an experienced cordial maker for the Southland Soda Water Manufactory in Esk Street. The following year he married Margaret Hickey (1838-1900) on the 1st of October. All the seven children that followed (1865-1876) were born in Invercargill.

<u>Maria Lestrange</u> was the daughter of <u>Edmund Lestrange</u> (1758-1828) of Hunstanton, King's Co. and grand-daughter of William Lestrange (1711-1773) of Kilcummin, King's Co. This Lestrange line can be traced back another 7 generations in Ireland to a Thomas Lestrange who had 16 children in the c16th century.

It seems very likely that Margaret Lestrange is related to this family which had branches in Westmeath, Dublin and Finistere in France. Is it a coincidence that the "I" mitochondrial DNA haplogroup has its highest frequency in Brittany, France where it is over 9 percent of the population in Finistere?

Ignatius Callaghan v. John Busby, John Fottrell and John Ennis. This was an action on a Policy of Assurance tried before Baron Smith on Saturday, the 13th June instant. Mr Brewster with whom was Mr Perrin and Mr Robert Holmes opened the declaration.

Mr Perrin stated the case. He began by saying this was an action brought against the defendants as mere nominal defendents; that in the month of February 1826 the plaintiff entered into an agreement with the Royal Irish Assurance Company to insure the life of Edmund L'Estrange of Hunstanton, in the King's County, for a sum of £500 and for which he was to pay an annual premium of £45 and which defendants accordingly acceded to, and issued a policy thereon, signed by them as three of the Directors of said Company. That in February 1827 the plaintiff paid a further premium of £45 and in February 1828 he made a third payment of £45 and that in March 1828 the said life in said policy died; that the Royal Irish Assurance Company thought proper to dissolve some time in the year 1827, and previous thereto entered into an arrangement with "The Asylum Life Company of London" for a valuable consideration, that said Asylum Company should take on them certain risks or Life Policies, which were stated in a schedule to the said contract annexed, among which was the policy the subject of the present action - and Gentleman of the Jury, let me tell you a fact, that the Asylum Company received, through their Agent, the premium of £45 payable in February 1828 on Mr L'Estrange's life, although they now come forward with a defence, the dishonourable nature of which I shall presently state to you. Gentleman, my client, the plaintiff, as he had a right to do, in the month of April 1828 forwarded to the Agents of said Company the necessary certificates of the death and burial of Mr L'Estrange; and expected when the usual time had elapsed, that he would, without further

trouble, have been paid the amount insured; but what was his surprise when on his demanding same, after a lapse of three months, to be informed The Asylum Company would not pay - and what was their defence truly, that he (plaintiff) was a Partner or Joint Proprietor of the Royal Irish Assurance Company, and therefore not legally entitled to receive; but, Gentlemen, I will show you that this dishonourable and dishonest defence will not avail. The Asylum Company – for let it not be supposed I attribute such motives to the nominal defendants - no, Gentlemen, they are as indignant and as enraged as you will feel at such a dishonourable defence - but what think you of the merits of it? We all know that in the several Insurance Companies, formed of numerous Proprietors, it must be for their advantage that such Proprietors should be at liberty to give the profit or benefit of any insurances they would have occasion to make to the Company of which they were members – but if a defence of the nature pleaded here, namely, that of being a Parter, was to be set up, why such business and profit must go elsewhere, and accordingly the Royal Irish Assurance Company, by an express covenant in their deed of agreement, section 53. I think it is, have expressly provided against such a defence, and declare that such Partner or Joint Proprietor shall be at liberty to insure and no such dishonourable or unjust advantage or defence be set up, and very wisely and very properly is such a covenant introduced. Why, Gentlemen, what do you think of the Asylum Company seeking for business in this City, where they have opened an Office, making such a defence; the Royal Irish Assurance Company altogether disavow it; but, Gentlemen, in order to bolster up the plea of Partnership, the Asylum Company have served a notice, stating that plaintiff had no interest, and that there was misrepresentation as to the state of health of Mr L'Estrange. Gentlemen, the plaintiff says this is all false, and I will be able to show you, by indisputable evidence, such is the case. If a case of misrepresentation, then I admit at once it is a good and just defence - but, Gentlemen, was it fair, was it just to take plaintiff's money for the premium without apprising him that as a Partner or Joint Proprietor they would not pay him if he should become entitled - but, as I before stated, this is not an available point in law for them – and having laid the evidence before you, I have no doubt of your verdict. George Hamilton was Secretary to the Royal Irish Assurance Company, proves handwriting of the three defendants to the policy; as also premium indorsed, admitting age and interest; and being cross-examined by Mr George Bennett, stated, he knew plaintiff to act as a Director of the Company, and received instructions from him relative to the business of said Company, and that plaintiff received fees as a Director, but that was the only money he knew him to receive.

<u>Thomas Beers</u> proved payment of the premiums on the part of the plaintiff, and the last was to one of the defendants.

<u>Dr Thomas Walters</u> examined by Mr Holmes – Is a Doctor of Medicine, residing in the King's County; knew Edmund L'Estrange, Esq. for upwards of 20 years, for the last 15 years very intimate; attended him and his family professionally on the 3rd February 1826, gave a certificate to satisfy an Insurance Company, which was a true certificate of his health, and Mr L'Estrange was then about 67 years of age; he died in his 70th year; there was not a more respectable gentleman in the county, nor a more honourable man anywhere, and would not on any account lend himself to any misrepresentation; witness visited him in his last illness, and stated the cause of his death; that at the time witness gave the certificate L'Estrange was an insurable life, and in a fair state at his time of life. He was cross-examined by Mr O'Loghlin stated, as a Medical man he might make a mistake in a man's health; the man himself might do so; knew L'Estrange several years, and attended him; he had not a tendency to consumption; his lungs were affected in February 1825 but did not know them so before; Dr Little, of Tuam, was called in; witness thought it necessary to call in Dr Little, the attack was very bad, but he perfectly recovered; never said, or heard Dr Little say, he was attacked with a spitting of blood; the attack in 1825 was for 8 or 10 days, and he was recovered in about two months; L'Estrange applied to witness to examine the state of his health; he stated the Insurance was for one year; L'Estrange was a most honourable man, and witness believed what he stated was true; witness gave the certificate for a

year, but would have given the certificate for the whole of life; Mr L'Estrange was in as good health after he recovered in 1825 as he was in for twenty years before, and was perfectly well at the time he gave the certificate; witness proved his death and burial; Plaintiff here closed his case.

Mr Bennett stated the case for the defence. He observed on the Asylum Company being called dishonest and dishonourable by the Learned Counsel for the Plaintiff, but that such was not the case. They had as good right to call on the Jury for their verdict as any other suitors. He would not call the Plaintiff dishonest or dishonourable, but state the circumstances, and leave the Public to draw deductions; L'Estrange and his Son were indebted to Plaintiff, but were quite solvent to pay any demands on them; Plaintiff had their Bill for £173, payable at nine months; Plaintiff, as one of a Company, insures L'Estrange's life for £500, and gets the Company to endorse on policy, age, and interest, should be admitted; that the only interest Plaintiff had in the life was £173, and he conceals from the Company the nature of his interest. As to his being a partner, I read to you the form of a proposal from a book of the Company, "Mrs Lawlor has appeared to us after Board hours", signed by Plaintiff. If Plaintiff's is a case of misrepresentation or concealment, and is not proved, he is not entitled to recover.

<u>Richard Kean</u> was produced to prove an attested copy of a bill and answer, and part of Defendant's answer was read. This was a bill of discovery filed in aid of the defence in action; some other documents were offered in evidence for the defence to show Defendant a partner, but as to them Baron Smith decided they were not admissible evidence.

The Deed of Partnership or Agreement between the Proprietors of the Royal Irish Assurance Company was produced and the handwriting of the Plaintiff thereto was proved by Mr Madden, no attending witness appearing to it. Mr Holmes objected to this mode of providing the deed. The case was closed for both sides.

Mr Baron Smith charged the Jury in favour of the Plaintiff, and directed them to find for the Plaintiff, adding, that he presumed the next allegation on the part of Insurance Companies would be, that evidence of a vitality, almost equal to a state of immortality, should be shown to a company, and that because a man was ill of a disease, from which he perfectly recovered before Insurance, and he died at the age of 70, he was not an insurable life. The Jury without leaving the box found for the plaintiff £500 damages and 6d costs. The Judge thought there was evidence of partnership, and then sent up an issue on the defendant's second plea, when the Jury found a verdict for the defendant on the second plea.
