Hotels made a valuable contribution to the early years of settlement in the Upper Hutt district.

The hotels provided shelter and resting place for weary travellers. It was also a place for the horses pulling stage coaches or carts to get watered, feed and rested.

It was a place for locals to gather for meetings to discuss various concerns and to establish and elect members for the Road and Education Boards.

Politian's would hold meetings especially leading up to elections.

In the early years of settlement when a death occupied unexpectedly a coroner's inquest would be held. These inquests were so often held at the nearest hotel. The corners reports record the name of the hotel and the proprietor as well as the names of the local men who were selected as jurors.

With respect to the Districts not comprised in the enclosed returns I must beg to draw your attention to my being without official means of procuring the information desired.
