The question was asked how old is the building at 111-113 Main Street Upper Hutt? In 2019 the building at 113 was occupied by Wheelers Shoe Store. The other half of the same building at 111 Main Street was occupied by Stunning Hair Limited.

By researching and recording the results in this document the story of the land, building, owners and occupiers will help to answer the question.

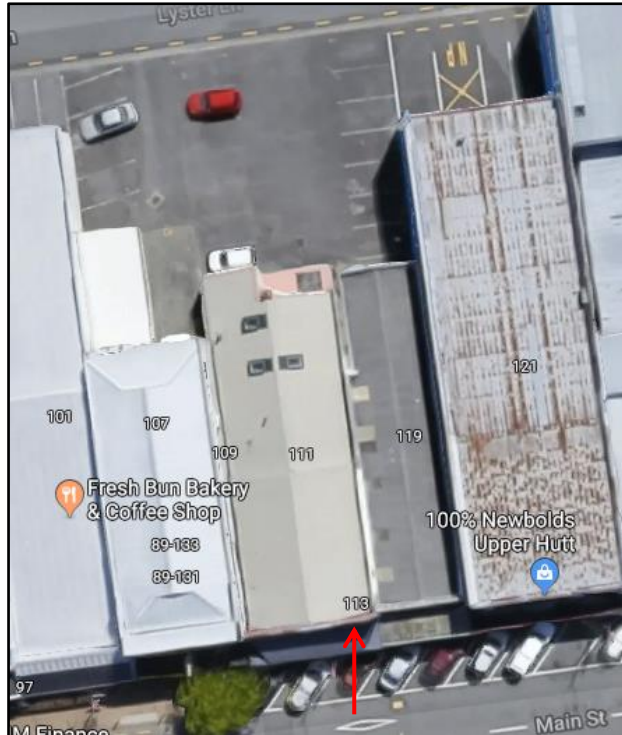
The façade of the building looks new when viewing from the front in Main Street. The back view of the building shows an older style when viewing from the back in Lyster lane.

### Original Art Deco frontage of 111 - 113 Main Street building

In 1925 an international exhibition of modern decorative and industrial arts was held in Paris. This exhibition was the beginning of Art Deco.

The art deco period made its appearance in New Zealand at the beginning of the 1930s. The rebuilding of Napier after the 03 February 1931 earthquake produced many art deco buildings.

The original frontage of the building at 111-113 Main Street Upper Hutt used an art deco design. This would lead one to believe that the building was built in the late 1930s.

Another art deco building established in Upper Hutt was the former Hercock Brothers Grocery & Crockery shop built in 1940. The Hercock building was demolished and Astrol Towers now known the CBD Towers was built on the same site.

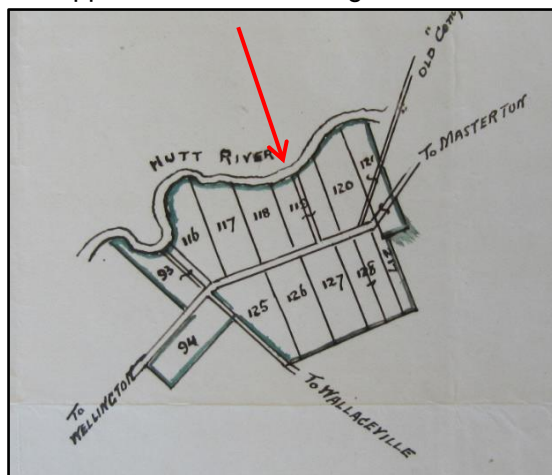
## The Land

Upper Hutt Section No 119 was surveyed in the 1840s and in the 1850s a Crown Grant of 50 acres was granted to James Brown and the other 50 acres to J Downey. By following the history of this section and its development we will learn about the owners and buildings.



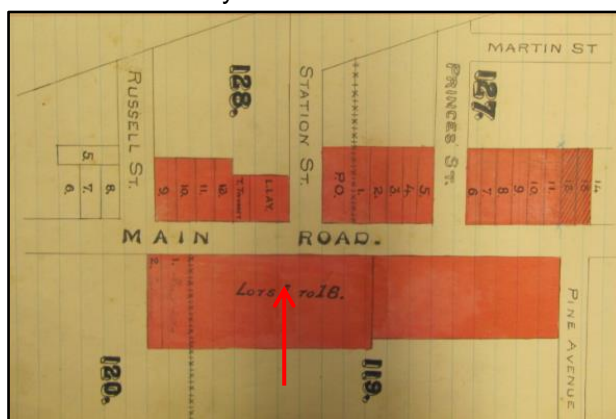

The 1908 Petition of householders desirous of establishing a local Town Borough included Section No 119 as part of the Upper Hutt Town Borough.

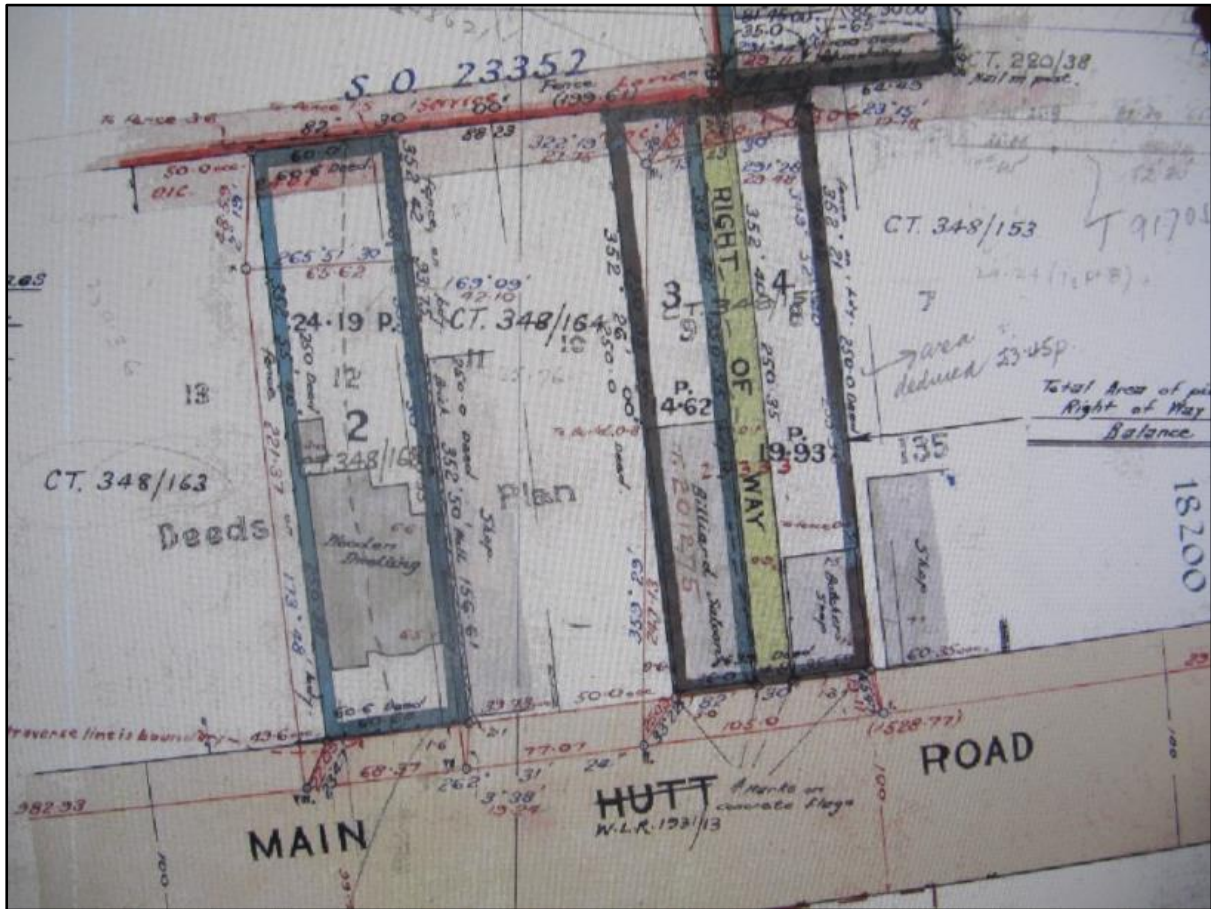
Section 119 became part of the Reayville Township development. When the land was first subdivided it was allotted lots numbers 1 to 18. The land description of 111-113 Main Street is property No 193447 Lots 3, & 4 drawn on Deed Plans DP 8921 and DP 23333. The Dominion Estate and Waldergrave Park Estate early subdivisions were also situated on Section 119.

The above DP 8921 dated 04 April 1928 details lots 3 & 4 on section 119. Facing Main Hutt Road (Main Street) lots 3 a billiard saloon, right of way and lot 4 butcher shop.

The Billiards Saloon on lot 3 to the left of the right of way is an earlier building. The billiard saloon in the new building was situated on lot 4 towards the back of the building. Access to the saloon was through a corridor in the middle of lots 3 and 4 where the right of way is shown on the above DP 8921.

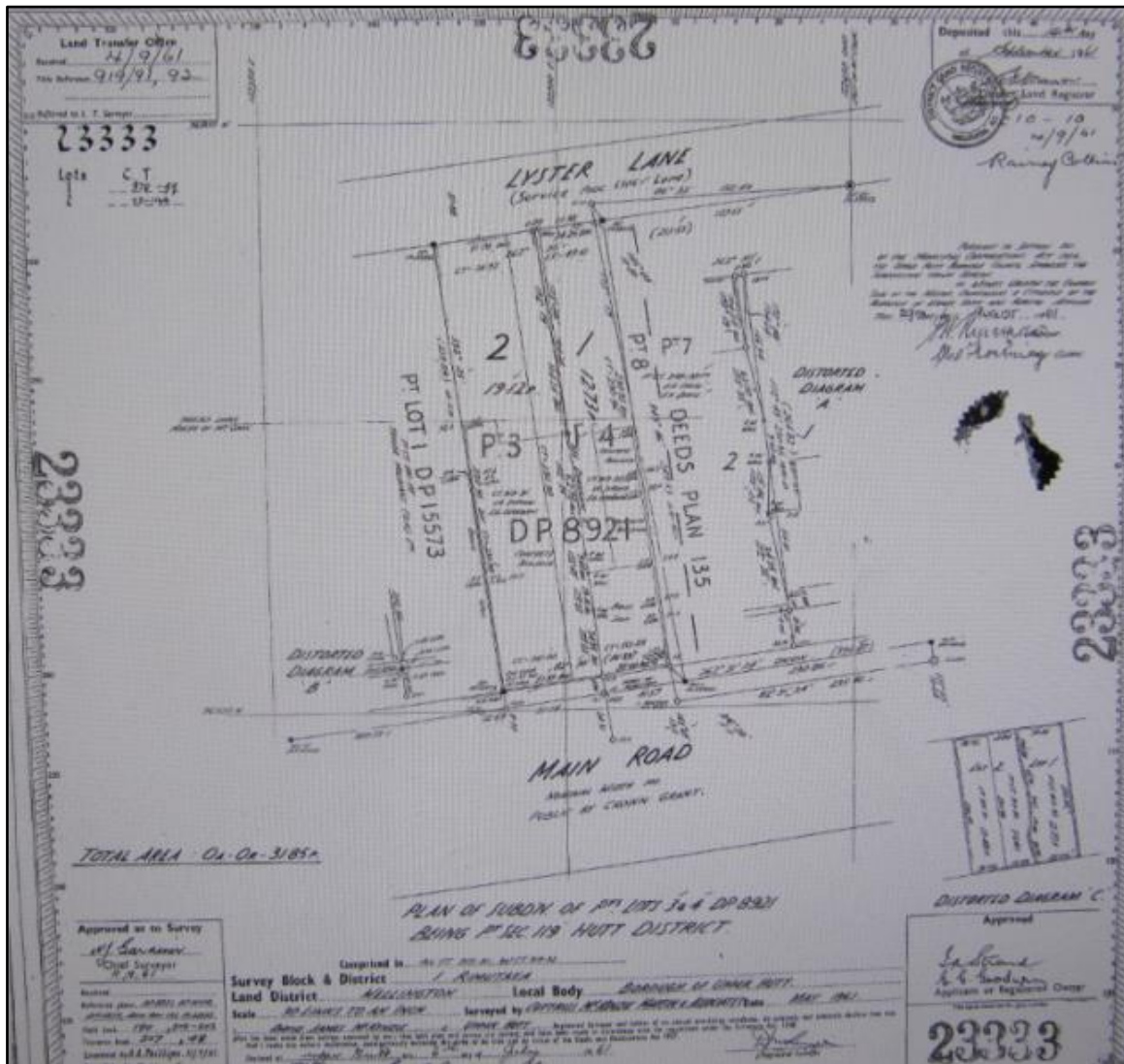
I have no information about the butcher shop situated at the front of lot 4 in this earlier building. In the new building at the front of lot 4 various bakeries occupied this area over a period of time.

There was a gap between the buildings on the right of lot 4. Inside of the new and existing building there are the remains a concrete space on the floor. This could lead one to believe that this was side and back door to the bakery shop.

Many years later another new building was established of the right of lot 4. This was once occupied by the Upper Hutt Meat Company Limited. Between Lots 2 and 3 on the right is a shop and on the left a grassed section.

The DP 23333 dated 06 July 1961 details lots 3 & 4 on section 119. The names recorded on the Deed plan are I A Stroud and E G Goodwin. Former DP 8921 covers the land between the Main Road and Lyster Lane.

On DP 8921 Pt 3 is CT 919.91 IA Stroud & EG Goodwin Concrete building. At the back of the land is CT 36.92. On the left it is CT 230.95 & CT 230.98. At the front is CT 36.00. On the right next to Pt 4 is CT 230.96

On DP 8921 Pt 4 is CT 919.92 IA Stroud & E G Goodwin Concrete building and Brick Shop at front of building. At the back is CT 49.10. At the front is CT 50.39. On the right is CT 230.95 & CT 230.96. The area between Pt 3 and Pt 4 is CT 230.96

To the left is Lot 1 DP 15573 is the name Taylor Holdings (UH) Limited. To the right is Pt 7 & Pt 8 DP 135 PT CT 348.153 Ltd are the names E A Ching & E H Davis.

**First Owners of building**

The building permits recorded the owners of the allotment as Keys, Goodwin & Stroud. The land Deed Plans DP 23333 recorded I A Stroud and E G Goodwin.

He had been in upper Hutt since 1951, first in Golders Road, then with Doctor Rainey in Wilkes Arcade, they were later joined by Doctor Ackroyd. In 1955 he studied obstetrics and gynaecology at Auckland Women's Hospital and then at the Royal College in England. He was appointed obstetrician-in-charge at Elderslea Maternity Hospital when it opened in 1961. A image was printed in the Leader on 22 December 1987. 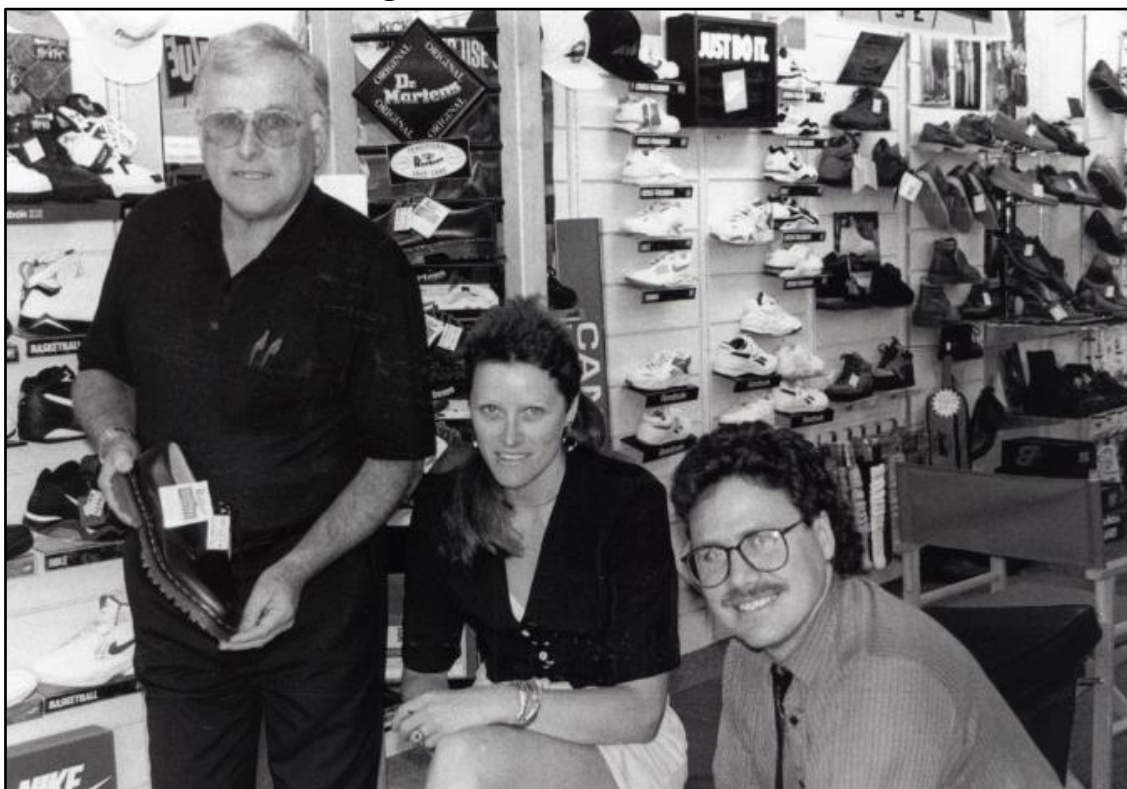

Angus Wheeler had worked for a large Auckland shoe company for 30 years, becoming their sales manager (he may have started in that position, but it seems unlikely). He was transferred to Wellington in 1959 to open a branch, and ten years later took over Le Taylor Shoe Store on the corner of Geange and Princes streets; he moved to 100 Main Street in 1979. Wheeler's moved to the corner of Main and Geange streets in the former Post Office building in May 2016, Avison's Home and Giftware moved into Wheeler's from No 110 across the street. The founder Angus died late in 2017 aged 92 an obituary was printed in the 31 January 2018 Leader. Date taken January 1993

## The Building

In 1938 Keys, Goodwin & Stroud applied to the Upper Hutt Borough Council for a Building permit. This new building would replace the old billiard saloon and include enough room for a barber and baker shop. The application was received on 19 May 1938. Permit No 1054 was issued 02 June 1938 to S R Norman (remarks 314C) on behalf of the Keys Estate. Information about additional building permits is located at the end of this document.

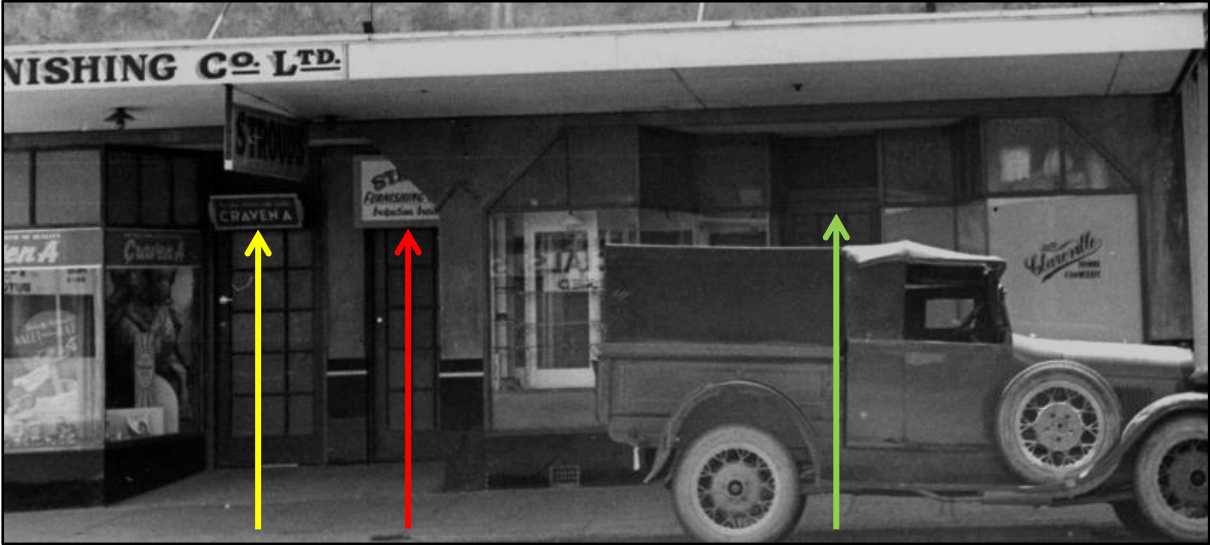

The doorway entrance in the middle of the building (red) was occupied by Stroud's Furnishing Company Limited operated by Frank Stroud.

The doorway entrance to the left of the building (yellow) was occupied by a Tobacconist shop. At one time Bob Styles managed the tobacconist and hairdressers shop.

There is a sign on the widow and above the door entrance reading "Craven A" which was a British brand of cigarettes previously owned by Carreras Tobacco Company and later owned and manufactured by Rothmans, Benson & Hedges.

There is another sign in another photo at the side of the building reading "Time for a Capstan" which was also a British brand of unfiltered cigarettes previously owned by WD & HO Wills and later owned by Imperial Brands.

There were other tobacconists and hairdressers in Upper Hutt with Craven A and Time for a Capstan signs.

## The Middle of the Building

**c1928 - 1946**

### Billiard Saloon – Ernest Armstrong Plummer

Around 1928 Ernest Plummer was operating a Billiard saloon in the first and original Upper Hutt billiard saloon. The first billiard saloon was a building on the south side of lot 3. In 1938 when the new billiard saloon was established on the same piece of land Ernest continued operating the billiard saloon. Access to the new billiard room was through a front entrance and down the corridor between the barbers shop on the south side and bakers shop on the north side of the same building. In 1946 the Billiard salon closed and Stroud's Furnishing shop opened and occupied the same area as the former billiard saloon.

#### Bookmaker Caught - Betting Material Found - A Fine of £25

A fine of £25 was imposed on Ernest Plummer by Mr T B McNeil, SM, at the Magistrate's Court to-day for carrying on business as a bookmaker. The accused was arrested at 10.30 o'clock last night as a result of a raid on a billiard saloon kept by him at Upper Hutt. Sub-Inspector Ward said that for a period of about two years the accused had been keeping a billiard saloon at Upper Hutt. During that time reports were received that bookmaking was being carried on in the saloon. Prior to taking over the saloon the accused had been a blacksmith employed at Upper Hutt, but apparently he had given up that position for the more lucrative one of bookmaking. A quantity of betting material was found in the possession of the accused. One sheet showed that twenty four bets had been taken and a total of £21 had been invested. In a notebook thirty three doubles were entered for the last Wellington Meeting, and twenty three straight out bets. The largest bet was one for £2, and the smallest one was 5s. Another book contained twenty one doubles and eighty six straight out bets. The largest was for £5 and the smallest 5s. The betting gear found in his possession shows that he is in a substantial way of business, said the Sub-Inspector. He says he is an agent for someone else, but as far as we can ascertain he is betting for himself. Mr A J Mazengarb, who entered a plea of guilty for the accused, said that the Sub-Inspector's statement that the accused had given up plating, horses for paying punters was not quite accurate. The accused had spent his whole life in a smithy, but his employer had gone into the motor carrying business. He needed only one man to deal with the requirements of the nearby farmers, so the accused had taken over the billiard saloon. He was not in a substantial way of business, and his income for last year was under £300

#### Raid on Bookmakers – Fines Total £105 – Convictions at Petone

A raid made by members of the Petone and Upper Hutt police on Thursday afternoon resulted in the appearance in the Petone Court yesterday morning of three men, Ernest Owen Oliver a hairdresser of Jackson Street Petone, Ernest Armstrong Plummer a billiard saloon keeper of Main Road Upper Hutt and John Purvis an agent of Tawai Road Trentham on charges of keeping their premises as a common gaming house. All pleaded guilty.



In Plummers case Detective Robinson stated that his premises were searched by Constable Williams and Morris. Betting material found indicated that he was in an extensive way. Slips etc. showed that during the Grand National Meeting he had taken bets totalling £172 16s 6d. The sum of £18 10s was found on his person. When he was before the Court in January 1931 for bookmaking he was fined £25. He was a married man with three children.

Mr A J Mazengarb said that Plummer was a blacksmith until motor traction put him out of business. He then took over a billiard saloon and had done what he suggested the majority of people in his line did. Men came to the saloon to play billiards and stayed to talk racing and the saloon keeper was pressed into helping them with their betting. He was only an agent and his commission was 1s I the £. There was considerable interest in Upper Hutt in the result of the Grand National because several of the horses came from the district. The defendant had a first class reputation in the district.

In 1938 Ernest Armstrong Plummer moved into the new premises of the billiard saloon.

At Upper Hutt Ernest Armstrong Plummer a billiard saloon keeper was charged with carrying on the business of a bookmaker and was also remanded on bail. He was arrested by Detective Sergeant Murch and Constable C E Stewart.

In May 1945 Ernest Plummer was tried again in Upper Hutt for bookmaking and fined £100.

The Sound of Music became a Tower Music branch in March 1995. Other shops visible are, from left, Priddle's Hairdressers (No 111), Independent Newspapers, and Four Seasons (women's wear, closed on 31 August 2017). The Sound of Music shop was later tenanted by a Sounds music outlet which eventually became defunct. The Sound of Music opened on 26 October 1966 in premises at Taylor House, Geange Street Upper Hutt. Perhaps the Kia Ora bakery was in a different building in Main Street and moved into the (111-113 Main Street) building at a later date.

Adam King (Creamo) Jowitt established the Kia Ora Cycle and Saddlery Depot in Upper Hutt. This business was operating around the same time as the Kia Ora Bakery. Perhaps Mr Jowitt had something to do with the Kia Ora Bakery shop.

The Kia Ora Bakery was operating around the same time as Majestic Bakery in Upper Hutt. In 1939 J McFadzean's was operating under the name Majestic Bakery.

I have been able to locate any further information about the Kia Ora Bakery or information about the owner or occupier.

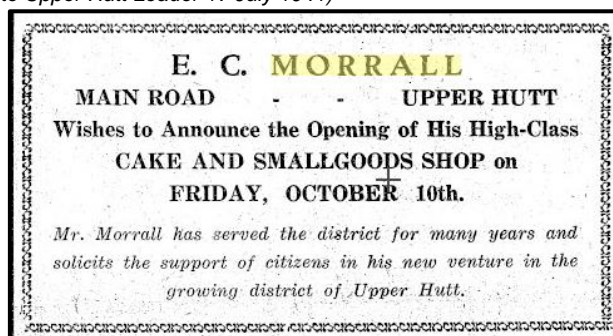

Around 1978 the building was opened up and the area that occupied the former bakery and Stroud Furnishing were merged together as one shop. This was around the time Dr Denys Heginbotham took over the ownership of the building.

### **The South side of the Building**

For many years a tobacconist and hairdressing shop occupied the south side of the building. In 1938 Robert Henry Styles occupation hairdresser resided in Upper Hutt. A 1940 newspaper article recorded that Robert managed Mr Benges's tobacconists shop. Perhaps Mr Benges occupied the tobacconist from 1938 to 1940 or he may have had a different manager occupying the new building. But who was this Mr Benges?

#Another Staunch Club-Member - Mr. R. Styles - While having my unruly mop of hair made presentable the other day, I asked Mr Bob Styles who was doing the shearing for a few facts regarding his association with the local Rugby Club. Between the whirr of the four nought clippers and the snipping of the scissors, I elicited a bit o! information which together with some more that I already had, only went to show how some people can hide their light under a bushel for Bob's Club activities certainly, place him among those whom we term Staunch Club members. As Player - In 1921 when Bob linked up with the Upper Hutt Rugby Football Club, there were only two fields in the district, one at Maidstone Park and the other at Quinn's Post. That year and the following season Bob played for the top Club team, the 3rd Grade Intermediates team mates still living in Upper Hutt being Tim Stroud, Doug Bucknell, Eric Stroud, and Ernie Gellen Committee Member - It was in 1926 Bob first became a member of the Management Committee which Included the following among its members, H J Benge, Darcy Auckram, the late Charlie Clark and Dave Tidswell. The late Mr H Marshall then proprietor of the Provincial Hotel was also a member of the Committee and it was he who was instrumental in getting the Club's first gymnasium, the Red Shed behind the hotel mentioned in a previous article. After a further term on the Management Committee the following year, Bob remained in the background officially, for a few years. Elected To Executive Again – In 1937 Bob, was again appointed a member of the Management Committee and continued in that executive position until 1941, being also a delegate to the Wellington Rugby Football Union in the latter year. Home Guard duties were Bob's main consideration for the next two years but he once more joined the Committee in 1944. I have been unable to trace any further details about the bakery shop. To locate additional information I will have to research the Upper Hutt Leader newspapers from 1964 onwards.
