James Bell sworn – I am in the employ of Mr Barton as superintendent of a grazing station near Mungaroa on the east coast of New Zealand (continues giving details of a dispute with a party of Maoris)

Wellington - 10th March 1845 - Richard Barton of the Hutt Valley, Port Nicholson, Esquire, states on oath that more than two years ago, in January, 1843, I met with the chief E Kai,

some of whose people had been working for me at clearing land, and he requested me to go to Wairarapa and instruct the natives how to clear land, and grow grain, and said that he would give me some land to begin with. He afterwards visited me on the Hutt, and repeated his request, and I gave him some presents of clothing, and grain and other things. E Kai was soon afterwards drowned at Wairarapa, and I gave up all thoughts of going there. In November, 1844, two natives brought me a letter signed by several others, stating that E Kai had set apart some land for me before his death, and that all parties wished me to go and occupy it. I went the following month and saw it, and entered into an engagement for it for a term of years, at twelve pounds per year. The natives set up all the boundary stones, and signed a deed, men, women, and children, and I took possession of it in January, of this year, by sending up a herd of cattle, and a flock of sheep, and three people with stores for twelve months. The natives built a house for me before my arrival. I placed James Bell in charge of the station with two assistants. Charles Jones, and James Cameron. The value of my stores amounted to between fifty and sixty pounds. (Signed) R. Barton. Sworn before us this tenth day of March, 1845. Wellington, New Zealand. (signed) Chas. Clifford, J. P. W. Wakefield J. P.

To the Electors of the Hutt - Upper Hutt, March 7, 1861. Gentlemen - I have been asked by a great many Electors both in my own immediate neighbourhood, and also in the Lower Valley, to offer myself as one of your representatives in the Provincial Council. I will be very candid, with you and frankly state, that, whilst I am sensible of this mark of confidence, yet I am reluctant, at my time of life, to add to the many claims I already have on my time. This reluctance I have only been induced to overcome, upon being convinced, that it is left to me to perform a public duty, which other younger men have declined. I, in common with a great many other Electors, have felt the injuries which have been inflicted on this Province during the last 3 or 4 years, by the conflict that has been perpetuated between the Legislature and Executive. We have sought, and at length succeeded to obtaining a constitutional. Release from this deadlock, and it would be manifestly inconsistent in us now to shrink from the consequences of our own act, by neglecting to bring forward candidates for the new council, and so permitting judgment to go as it were, by default. Having asked for and obtained a new trial, I for one, feel that I cannot refuse, if called on, to appear in court at the re-hearing. Having explained the circumstances of me becoming a candidate; I have only to add that, whilst I am generally a sup- porter of Dr. Featherston's Government, yet, if you elect me, I shall enter the Council wholly unfettered and independent, and will only give my support to such measures as I can approve and justify to my constituents. As one of your oldest resident settlers, I necessarily take a great interest in the Hutt, and shall not fail to watch especially its local interests, and endeavour to obtain for our district its fair share of the public expenditure. I have the honor to be Gentlemen, Your obedient servant, RICHARD BARTON

Would you please be kind enough to inform me whether the Government would grant to me a licence (or permission) to cut timber on unoccupied land up the Taw-nui river some four or five miles above the Pirinua native reserve. I believe the Native Reserve formerly belonged to the original owner of the land which I now own in the Taranganui block but owing to some arrangement made with the Natives they now have possession of it which leaves me without any timber for fencing & building purposes.

**Richard Barton** (1790-1866) was the first European resident of Trentham Upper Hutt in New Zealand. He was born on 30 August 1790 in Newport, Isle of Wight[1]. He arrived in Wellington in 1840 on the "Oriental" the second of four settler ships and in 1841 purchased 100-acres for a farm in Upper Hutt Valley [2]. He named his estate Trentham in honour of the Duke of Sutherland, one of whose titles is Viscount Trentham, of Trentham in the County of Stafford. (Before emigrating to New Zealand, Barton has been Supervisor at the then Trentham Hall) Much of his former estate is now Trentham memorial Park, which includes the native bush remnant known as Barton's Bush. The surrounding suburb of Trentham also takes its name from his estate. Exactly when Barton and his family began living on the

Trentham estate is unclear from various historical sources. Although he appears to have built a slab house on his purchase around 1841, the Trentham Parish histories indicate that he and his third wife, Hannah, whom he married circa 1843, only settled on the estate in 1846. During the intervening 5 years it seems Barton may have assisted, perhaps supervised, the surveying the surrounding country for the Wellington Company. The Barton homestead was located near the corner of the Main Road (now Fergusson Drive) and Camp Road (now Camp Street) and overlooked what is now Trentham Memorial Park [3]. Barton appears to have acquired more land, as his estate is described as lying to the west of the Main Road from Quinn's Post to Silverstream on both sides of the river. By 27 December 1861, Barton is described as the chief landowner and magistrate of the district. This being when arrangements were bring made to establish and Anglican Church mission at Trentham. Early in 1862 it appears that Barton extended his own house to accommodate the church missionaries as well as donating land for the establishment of a church. Richard Barton died on 20 August 1866 and was buried in Upper Hutt at St John's Anglican Church cemetery [4 & 5].

Situated in Trentham Memorial Park in Upper Hutt is a reserve known to locals as Barton Bush which was a portion of the original land owned by Richard BARTON. Situated at the south entrance on Fergusson Drive is a plaque that reads:

Trentham Memorial Park comprises of 49 hectares of Parkland featuring remnant native forest and playing fields.

In 1841 when the entire valley and surrounding hills was thick bush Richard BARTON and his wife Hannah purchases 100 acres of land including the area which is now Trentham Memorial Park. Mr Richard BARTON named the estate Trentham after his English childhood home. The estate extended to the north from what is today Quinn's Post to Silverstream on the South and across the Hutt River to the western hills.

The BARTONS intentionally developed their land as a park modelling it on large stately English estates developing some areas for farming some of park land and leaving an area in natural bush. Overlooking the park at the junction of Main Road (Fergusson Drive) and Camp Road (Camp Street) the Barton's built the Manor house. The house was extended until it eventually comprised a total 22 rooms with six staircases. Boy Scouts dismantled the house in 1939 for a Jamboree after it had been gutted by fire. No signs of the house remain today. Two tall kahikatea trees were used as radio masts by the Barton's. Their height meant the aerials could be seen floating high above the bush. Other tall trees in the park today include a belt of Redwood trees (*Sequoia sempervirens*) planted by the Barton's in 1909 to screen the homestead.

The Ngati Ira Maori lived in the Upper Hutt area until 1820 when they were expelled from the region by Te Rauparaha's raiding parties. The Ngati Tama from Taranaki established two villages in the Upper Hutt area one of these was near Silverstream. The Maori name for

Trentham area was Mauwaihakona meaning the stream where water had to be scooped from it. The Maori used a prominent stand of kahikateas in the park near the corner of Camp Road as a directional landmark. In 1950 a Maori canoe was dug out of the Mawaihakona. A pool in the Hutt River adjoining the park was used by troops from Trentham Military Camp for swimmers during both world wars and was known as Soldiers Pool. This section of the River was straightened during the construction of the River Road. On the western side of the Hutt River south of Moonshine Bridge a notice has been erected alongside the Soldiers Pool. In 1924 the first discussion to acquire the area known as Barton's Bush were held with the Barton family and representation to the Minister of Lands was made seeking his assistance. At that time the owners were embarking on a large clearing programme which would result in the destruction of this stand of bush. Attempts to acquire the property as a public reserve were continued but it was not until 1950 that the purchase for £26,000 was made. The finance was provided by public subscription with equal contributions by the Hutt County Council and the Upper Hutt Borough Council and a War Memorial subsidy of £13,000. The land was purchased for public remnant as the only area left that indicated what the valley forest was like before the area was settled by Europeans. The park was extended over the years to its present size by way of purchase by the crown, gifts by the Barton family the Hutt County Council and the Upper Hutt Borough Council. The park provides for many formal sports including cricket, soccer, rugby, harriers, marching and axe-men wood chopping. In addition information facilities such as picnic areas, a children's play area, formed and sign posted tracks and a fitness circuit are provided. Major attractions such as the Summer Carnival, circuses and regional sports events are held within the Park.

- Barton Richard 1790-1866 (items) = New Zealand Company agent and runholder. Born on Isle of Wight. Was employed as a superintendent on 'Trentham', the estate of the Duke of Sutherland. In 1839, became involved in the New Zealand Company, and persuaded more than 40 Highlanders as recruits for the settlement. Arrived in New Zealand on the 'Oriental' in 1840, and took up land on the Hutt River, where he formed a settlement at Trentham, employing several of the Scottish recruits. In 1843 (or 1844?) he married Hannah Butler (1817-1894). He formed a sheep station at White Rock before 1847 and later extended his holdings. See DNZB / Scholefield (Vol 1, p46)
- Barton Hannah 1817-1894 (items) married Richard Barton (1790-1866) in 1844. Daughter of Rev John Gare Butler (1719-1841) See DNZB / Scholefield (p46, p127) Of Barton's Bush and Trentham Upper Hutt
- Dallas J P G fl 1839 (items) = JPG Dallas & R Saunders of London wrote to Richard Barton in 1839 re land in the Colony
- Barton Richard fl 1926-1927 (items) = of Upper Plain Masterton. Johannes Anderson Librarian Alexander Turnbull Library wrote to Mr Barton in 1926 regarding historical papers in his possession
- Pirinoa Station Wairarapa (Items) = Original owner was Richard Barton who sold the property (2617 acres) to Duncan McDougall in 1877. He farmed the property until he was accidentally drowned in Lake Onoke in Apr 1891. His widow Ellen, with the help of her sons, continued to farm the property. In 1920s her son James, who had been running the farm, purchased a property at Martinborough, and his brother Ramsay (Dod) took over until his death in 1940. During the remaining war years Pirinoa was managed by Jack O'Brien until Duncan Disdbury took over in 1948. His son Tony took over in 1971. The station received the NZ Century Farm & Station award in 2006 to mark 100 years of continuous ownership by one family
- McDougall Duncan 1845-1891 (items) = Born in Oban, Scotland and travelled to New Zealand when he was about 20 years of age. Ran an accommodation house at the Upper Rakaia. There he met and married Ellen Rutherford, daughter of James and Mary Rutherford of Mount Possession. The couple had nine children (6 sons & 3 daughters, one being Euphemia who married Harold Guy Didsbury). He sold the accommodation



house and purchased a property in northern Hawke's Bay called 'Pohui'. In 1877 he purchased Pirinoa in the Wairarapa from Richard Barton. He became the first chairman of the Pininoa School in 1890. He drowned in Lake Onoke on 25 Apr 1891, and running of the farm was taken over by his eldest son James Duncan McDougall (1870-1945).

- Didsbury Anthony Colin 1945 (items) = Farmer, Pirinoa Station, South Wairarapa. Son of Duncan McDougall Didsbury and Helen (nee Allard); and great-grandson of Duncan McDougall who purchased the property from Richard Barton in 1877. Tony took over the running of the station from his father in 1971. In 2004 the management of the station was handed over to his eldest son Guy
- Barton Cranleigh Harper 1890-1975 (items) = Author, lawyer and artist resident in Redcliffs, Christchurch for many years until his death. Great-grandson of the Rev Richard Taylor. Born Feilding, the son of Margaret Barton, nee Harper, he graduated from Victoria University College in 1912 with a Bachelor of Law degree. He practised law in Christchurch, before going overseas in 1921 and studied art at the Slade School, London, 1924-1927. He returned to New Zealand in 1930. In later life, he was awarded an MBE. He travelled extensively throughout the world over many years, painting landscapes in watercolours. He also painted many watercolours of New Zealand. Large collections of his watercolours are held in the Alexander Turnbull Library and in Canterbury Museum.
- Barton George Elliot 1827-1906 (items) = Lawyer, judge and politician. Born in Ireland. Came to Australia in 1864 and worked for J B Bennett, a Melbourne solicitor. Was a land leaguer during the agitation against the squatter monopoly and went into Parliament as a member for Melbourne North. Bennett's firm depended on the squatters, so he resigned his seat and moved to Dunedin. He practised with George Howorth. A successful action for slander taken against him led him to Wellington where he became a Member of Parliament. He then lived in Britain and became involved with a land company floated to settle the Te Puke Block. He later returned to New Zealand and became a judge for the Land Court until 1895. After his wife died he travelled the world finally settling in Paris. See DNZB / Scholefield (Vol 1, p46)
- Phoenix Cricket Club (items) = Began in 1881, according to Louis Ward's "Early Wellington" page 502. Members in 1886-1887 included: Mr Levin (chairman), Mr Duncan (vice-chairman), Mr A Motley, E Wilson-Duret, S Waters, E Widdop, J Riley, H McKean, J Varnham, A R Nicholls, W Harwicke, Mr Gully, Mr Haybittle, Messrs W & C Godden, T Sayers, Mr Montgomery, P McIntyre, Mr Ronaldson, Mr Barton, Mr Pitt, Mr Peat, Mr Whitfield, Mr F Allen
- Butler John Gare (Rev) 1781-1841 (items) = Butler was mission superintendent in New Zealand 1819-1823, until deported to NSW by Marsden. In 1798 married Hannah Hitchman (d 1852). Father of Samuel Butler (1800-1836) and Hannah Barton (nee Butler; b 1817). See DNZB / Scholefield (Vol 1, p126-127). Buried on Gear Island; his grave was later washed away in a flood (from notes by Martin Nestor in Gear Meat Company papers)
- Barton J P R fl 1855 (Items)
- Barton Eleanor 1872-1960 (items) = Australian co-operative movement and labour party worker
- Barton T Trehearne fl 1899 (items)
- Barton F R fl 1930 (items)
- Barton Phillip Lionel 1925-2010 (items) = Born England; RAF, 1943-1952 and RNZAF, 1952-1965; National Library Service, 1965 and Map Librarian, Alexander Turnbull Library, 1973-1986 (MS-Papers-5420-2). Died 17 June 2010, aged 83 years
- Barton Connie Miriam 1912-2000 = see Purdue Constance Miriam 1912-2000 (items)
- Barton Tuwhakaririka fl 1953 (items)
- Barton Phil 1925-2010 = see Barton Phillip Lionel 1925-2010 (items)
- Barton Edmund (Rt Hon Sir) 1849-1920 (items) = NSW lawyer and politician. First Australian Prime Minister 1901-1903

- Barton John 1823-1902 (items) Engineer and surveyor. Built the homestead at Trentham in 1855. See Early New Zealand engineers / F W Turkert, page 106. His son John Barton (junior) 1851-1923 was also an engineer and surveyor (see C A Lawn's unpublished history 'The Pioneer land surveyors of NZ')
- Barton Jill 1929-1996 (items = wife of Tom Barton writer
- Barton Tina fl 1979 (items)
- Barton Robert fl 1892 (items) = operated Lake Ferry ferry
- Barton George Paterson 1925-2011 (items) = Barrister. He was the first New Zealander to be elected President of the United Bible Societies, the world's largest bible society. Bestowed by Samoa in 1982 with the title 'matai', and was the first non-politician to be granted this honour. Associated with the Bank of New Zealand enquiry of 1992. - Barton Peter fl 1978 (items) = Wrote letter from Barton Queensland 1978
- Barton Shirley d 1987 (items) As CORSO liaison officer, worked with Rewi Alley in China; later Secretary of the New Zealand-China Friendship Association.
- Barton family (items) = The family of Cranleigh and Onslow Barton
- Barton Julia fl 1974 (items) = Musician
- Barton William 1858-1938 (items) = Barrister and farmer. Student at Wellington College from 1875-1876. Station owner, White Rock, Featherston. Gained Foundation Scholarship and B.A. at St John's College, Cambridge with Honours. Barrister and solicitor in Wellington from 1885. See "The early history of Wellington College" / Frank M Leckie (P 373.931 LEC 1934). Name and information transcribed from back of file print of 1/1-134841. Married to Lucy (nee Studholme; d 1944). Had 6 daughters, including one who died in childhood. Another daughter, Mabel Alexandra (Aline) Quin (nee Barton) was one of the first New Zealand women to learn to fly and was the first to fly her own plane, 'Gypsy Moth' overseas (Nairobi). - Barton Ruth 1945 (items) = Associate Professor History Department at the University of Auckland

- Barton Robert Aitken 1921-2007 (items) = Reader in Animal Science Massey University Palmerston North in 1987 See NZ National Bibliography Vol 2 A-H page 96/Bagnall
- Barton George Burnett 1936-1901 (items) = Journalist. Book reviewer. Born in Sydney, studied there (read law from 1856), and worked as a journalist there. In 1868 he succeeded Vogel as editor of the Otago Daily Times, a position he held for almost 3 years; edited "The New Zealand Jurist", and "Practical statistics of new Zealand". He returned to Sydney, as a journalist, and lecturer in English at Sydney University. See DNZB / Scholefield (Vol 1, p45-46)
- Barton Karli fl 1993 (items) = Trombone player
- Barton Wally fl 1950 (items) = Member of the Kiwi concert party in 1950
- Barton Chapple Virginia 1945 (items) = Sculptor. Born in Palmerston North; studied at School of Design, Wellington. Lived in London for 16 years, worked in a studio with other sculptors and painters. While there met Kenneth and Joan Armitage, and worked in their studio at Highgate. On return to NZ in 1980 she had several exhibitions. Sister of Chris Brooke-White
- Barton Caroline 1808?-1876 (items) = Governess. Daughter of a London merchant; she lived in Mulgrave Street, Wellington, and had been in New Zealand for 9 years at the time of her death in 1876. Buried at Bolton Street Cemetery, Wellington
- Macalister Mazengarb (firm) (items) = Wellington law firm established in 1912 by J.S. Barton. Early partners were O.C. Mazengarb, E.P. Hay and R.L. Macalister
- Barton Len 1906-1996 (items) = Electrical engineer living in Hawera A keen musician

- BARTON Mary fl 1990 (items) = Of Opoho Dunedin in 1990 intending poet
- Barton R N fl 1952 (items)
- Barton Laley fl 1907 (items) = Wrote a letter from the Chateau Tongariro
- Bartin Bill fl 1977 (items) = Of Palmerston North in 1977 and had just accepted a job in Swaziland
