Memorandum of Agreement made the thirteenth day of January One thousand eight hundred and seventy Between Edward William MILLS of the City of Wellington in the Province of Wellington Ironmonger and Iron-founder of the one part and Abraham HARRIS of the Hutt district in the same Province carter of the other part Do hereby the said Edward Williams MILLS agrees to sell to the said Abraham HARRIS and the said Abraham HARRIS agrees to purchase for Five hundred pounds all that the agreement for the lease of a piece of Land at Pakuratahi in the said Province of Wellington containing three and half acres or thereabouts being part of Section Number ten on the Plan of the said District formerly made with Terry [sic] and cave [sic] afterward wish and now held by him the said Edward William MILLS by and under Walter HODDER all that the Mill machinery engine coiler saws breaking down frame furniture and tools now being in and about said premises Together wish the right of cutting timber on the land of the said Walter HODDER as under agreement with the said to Walter Hodder and also all the right title and interest of him the said Edward William MILLS in and to an agreement for a lease of part of Section Number Seven on the plan of the same District made and agreement to be granted to one E MORGAN and to afterwards with him the said Edward Williams MILLS by certain Aboriginal Natives and other persons entitled in that behalf and the said Abraham HARRIS agrees to pay for the premises the said sum of Five hundred Pounds in manner following that is to say One Hundred and Sixty six Pounds thirteen shillings and four pence on the seventh day of March next One hundred and sixty six Pounds thirteen shillings and four pence on the seventh day of April and the balance or sum of lone hundred and Sixty six pounds thirteen shillings and four pence on the Seventh day of June now next and the said Edward William MILLS agrees that on payment of the last of such amounts he the said Edward William MILLS his executors or administrators will and shall execute an assignment of all such his interest aforesaid It being understood that the said Abraham HARRIS purchases and takes the said Edward William MILLS sells only and agrees to assign only such interest in the said land as he the said Edward William

MILLS now possesses but that the said Edward William MILLS will assist the said Abraham HARRIS so far as in him lay but at the costs of the said Abraham HARRIS to procure valid leases from the said Walter Hodder and the Natives That in the meantime the said Edward William MILLS will grant and the said Abraham HARRIS shall accept a lease of the said Land Mill, Mill Machine tools and premises hereby agree to be sold and continue a tenant under the same until payment of the full sum of Five hundred Pounds that if default shall be made in payment of any of the said sums or any part thereof the unpaid portion shall bear interest after the rate of Ten Pounds per centum per annum and the said Edward William MILLS shall have the option of cancelling this agreement at any time after default and reselling the premises

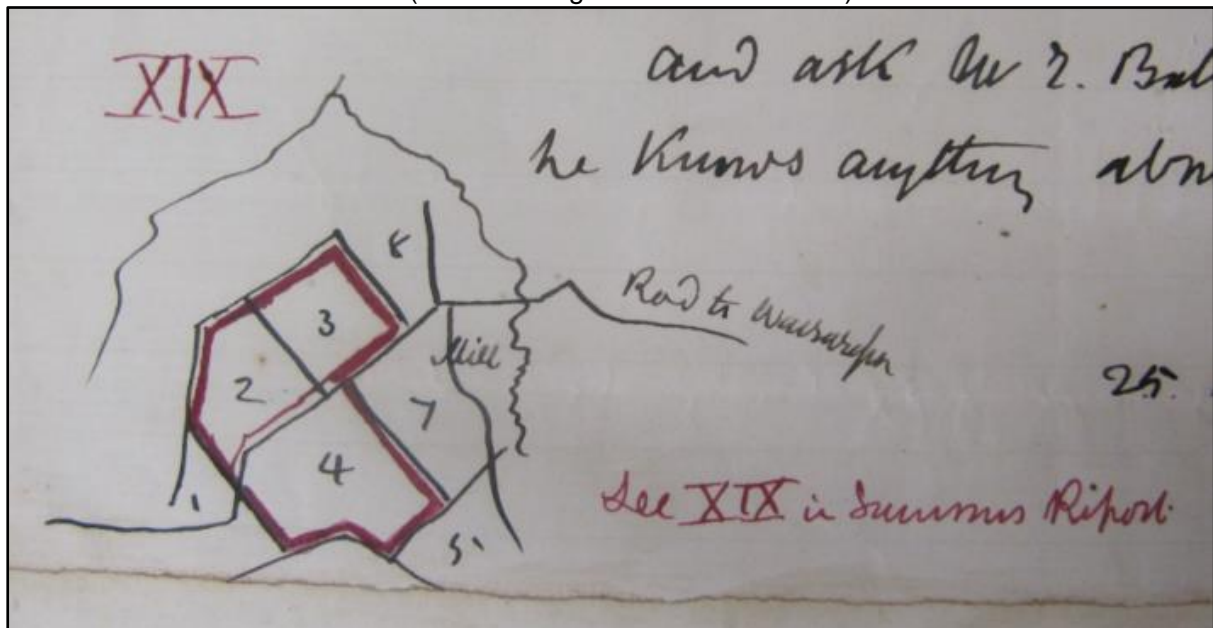

Death of Mr E W Mills - Every circle of city life will be touched with grief at the death of Mr Edward William Mills, the well-known iron merchant, who passed away at Sayes Court, The Terrace, shortly before 1 o'clock this afternoon. Mr Mills was a familiar figure in city life, and his friends throughout the colony were legion. His illness came upon him with that suddenness attached to strokes of apoplexy, and from Friday no hopes were entertained of his recovery, although an unexpected rally took place on Saturday, when for a short time he recovered consciousness. Serious haemorrhage and paralysis had followed the stroke. The ancestors of the deceased gentleman settled in Winchester, Hants, during the reign of Queen Elizabeth, and resided on their estate there until 1838. Dr Edward Shorter, an inventor of note including among other things the screw propeller was a grand uncle of the deceased. Mr Mills was born in August of 1829, at Kensington, London, and twelve years later was brought out to New Zealand with the family immigration on the ship Birman, which arrived in Port Nicholson on the 1st of March 1842. Shortly after his arrival the lad was put to work under a brother of Dr Norman McLeod, leaving this position only to assist his father (Mr Chas. Mills who died in 1862) in carrying out Building contracts for the Imperial Government. This was succeeded by experiences on the goldfields in Australia, Ballarat and Forest Creek rushes being among those attended. In his 24th year he was back in Wellington, and then set to work upon the foundation of the business house with

which his name has since been connected. There was scarcely a phase of Wellington's business life with which Mr Mills was not connected, and in the promoting and directing of public enterprises he played a prominent and active part. The City Tramways Company and the Patent Slip Company were two prominent works with the promotion of which he was identified, and for ten years he was a director of the Colonial Insurance Company (merged into the Commercial Union Insurance Co.). The well-known Lion Foundry, which is now in the hands of Mr Cable, was founded by Mr Mills so long as 1856. The original site of the foundry was that upon which the late residence of the deceased was built. As in business life, so in social circles, Mr Mills was a conspicuous figure. He was one of the first members of the choir of St. Paul's Pro-Cathedral, and a life-long member of the Church. He was a member of the Wellington Club, and took a great interest in the Chamber of Commerce, of which he was President in 1889, and he was a P.M. in the Masonic Order, being a member of the Pacific Lodge. Though often requested to allow himself to be nominated for political honours, and also for the Mayoralty, he steadfastly declined, but he sat on the old Town Board, and from 1870 till 1877 on the City Council. It was in 1876 that he was appointed a J.P., and was a member of the Licensing Committee. As a volunteer he did his duty on sentry-go in the days when the city was threatened by a descent of the Maoris, then joined the No. 1 Company Royal Rifle Volunteers, rising to its captaincy, which he held till disbandment. Afterwards he was given the captaincy of No. 1 Company of the Militia, and his name was placed on the Retired List. But in no portion of our life did Mr Mills show more interest than in his connection with yachting affairs. From the days when whaleboats were the only vehicles for aquatic competitions right down to these later days, he displayed the utmost liberality in his encouragement of the sport. It was at his suggestion and by personal canvass that the Port Nicholson Yacht Club was formed, and the post of Commodore has been rendered vacant by his death. Mr Mills was in 1854 married to the eldest daughter of Captain Wright, and he is survived by Mrs Mills and three sons and five daughters, the latter being all married. They were married respectively to Messrs B Holmwood (of Lee Kent), G C Russell, A Anderson (Christchurch), Captain W G Grey and Mr W J Napier, M.H.R. (Auckland). The eldest son, Mr E C E Mills, who has taken a prominent part in assisting in the management of the business of E W Mills and Co., is at present in New York, and has cabled over that he will leave for New Zealand in a few days. Messrs Frank and John Mills, with Mrs Anderson, and Captain and Mrs Grey, were present when the deceased passed away. Mr and Mrs Napier will arrive in town tonight. The funeral will take place on Wednesday morning.
