Duncan ROBERTSON was born but the date and place are unknown.

Duncan ROBERTSON arrived in New Zealand before 1841.

1841 correspondence records at Archives New Zealand in Wellington record [1] Duncan Robertson [2] Duncan Robertson and his wife left on Monday morning

An 1842 newspaper article mentioned a Mrs Robertson giving evidence in a court case against Mr Wyeth. Mr Wyeth later settled in Silverstream which was sometimes referred to in early newspapers as Stokes Valley. In 1853 Duncan Robertson was leasehold in Stokes Valley Upper Hutt. Perhaps there is a connection.

There was a baptism on the 24 March 1850 at the Hutt Wellington New Zealand. A Duncan Robertson was recorded but it is not known if he was the children, father or witness.
