## 1871 Upper Hutt no Justice of Peace

- 09 November 1871 letter from CHS Nicholls Trentham Parsonage Upper Hutt Sir I have the honour to acknowledge receipt of yours of the 06<sup>th</sup> instant stating that no appointment of Justice of the Peace is currently planned at the Upper Hutt. I have no personal feelings or interest in this matter but I regret that no steps are intended to be taken as I feel convinced that some such appointment is very much required and it has the appoint of Mr Crawford the present R.M. I have the honour to be Sir your most obedient servant CHS Nicholls Foundation Equr. [sic] Per Asst. Law Office Wellington (written in red CHA Nicholls Regret that no JP is to be appointed at Upper Hutt 71/2868)
- 28 October 1871 letter from CHS Nicholls Trentham Upper Hutt Dear Sir I enclose a copy of a letter which I forwarded to you on the 28<sup>th</sup> of August instant. As I have received no reply I suppose it must have miscarried or have been overlooked in the tern of business I am dear sir yours faithfully C H Nicholls The Hon W Fox & Co Wellington (written in red Rev CHS Nicholls recommending apt. if a JP at Upper Hutt & offering his services 71/2794)
- 28 August 1871 Upper Hutt letter Dear Sir The one policeman stationed in this isolated place has often mentioned that the advantage of having at least one magistrate here. Often information has to be taken or a summons issued a long journey is necessary and in many ways the presence of a J.P. would be a benefit. Should you deem it advisable to appoint one & should not one else be found suitable for the office I should have no objection to act. I do not desire the appointment nor do I ask for it but I am willing to undertake the duties if required. In cases of little importance a J.P. could act and save the R.M. a long journey and perform the necessary work satisfactory I have the honour to be your servant CHS Nicholls to the Hon W Fox Wellington

## 1916 Upper Hutt requires extra Justices of the Peace

- 12 June 1916 memo from Stipendiary Magistrate D G A Cooper to Under Secretary Justice Department Wellington – Herewith I beg to enclose for your consideration a letter received from the Clerk of the S.M. Court Upper Hutt as to the insufficient number of Justices of the Peace in the Upper Hutt District
- 14 June 1916 memo from Under Secretary C B Jordan to D G A Cooper Esq SM Wellington

   I beg to acknowledge the receipt of your memorandum of the 12<sup>th</sup> instant forwarding a communication from the Clerk of Court at Upper Hutt with reference to the need for appointment of additional Justices of the Peace at Upper Hutt and in reply am directed by the Minister of Justice to inform you that the matter will receive consideration when further appointments to the Commission are being made.
- 10 the June 1916 memo from Clerk of Court J W McHolm to the Clerk of Magistrates Court Wellington Sir Re paucity of Justice of the Peace for Upper Hutt I have to report at present there are an insufficient number of Justices of the Peace for this District. There is only one in the Upper Hutt Township viz P D Davis Esq hitherto there were two but Mr G L Lay resigned last year. The next nearest to the Upper Hutt Township is a Mr Barber who lives at Trentham but owing to an unfortunate illness he is unable to officiate. Mr J Barton JP lives at Trentham 3 miles distant. As there are a great number of Affidavits &ct to be made owing to the increased work brought about by the Military Camp being here I would respectfully ask that this shortage of Justices be brought under the notice of the Justice Department with a view of having the vacancies caused by the resignation of Mr G D Lay and the illness of Mr Barber filled.
