He further states they tore down an old shed which stood on the section and fired the debris in order to show what they consider their undoubted ownership. Kells thereupon charged them with arson and a warrant was forwarded in due course to Constable Harnett who yesterday effected their arrest. It was anticipated that some trouble would be experienced in arresting the accused and an additional constable was despatched from town at the request of the complainant Robert James Kells but this extra assistance was not needed, the natives having already been taken into custody by Constable Harnett when his assistant arrived from town. The natives went with the officer quite willingly and were rather anxious than otherwise to be brought into Court so that an opportunity might be afforded for deciding the disputed title. As showing the friendly feeling of the Maoris towards the police it may be mentioned that one of them took Constable Harnett in a punt across the river which was flooded and after the arrest was obliged to put the officer and his prisoners back over the river again.

It appears that the alleged lunatic's name is Isaac Brown and it will be remembered that some two or three weeks ago he appeared repeatedly before the Magistrate first as a deserter from the barque *Cornuvia* when he accused the skipper and the mates as well as the seamen of cruelty. Brown was twice ordered back on board his vessel but was eventually sentenced to 14 days imprisonment. On the 16th September and again on the 15th October he received a sentence of seven days imprisonment. Since serving his last term Brown has gone out to seek work in the Hutt district.

There were wild rumours about the city last night that Mrs Baker had been badly injured but as a matter of fact she only sustained a small bump on the head and a scratch over the eyebrow. Searched prisoner on first taking him to the cell and took another knife from him. He must have had this one concealed. Mielsch reserved his defence and pleaded not guilty. He was committed for trial.

In a short speech the senior Justice of the Peace r P D Davis traced the history of the council's efforts to secure the new building. Mr R H Webb spoke on behalf of the legal practitioners. He congratulated the borough on having acquired such a handsome addition to its building as the present Courthouse. Mr Woodward added his felicitations to those already given and promised to convey to the Justice Department the borough's appreciation. That the council had got a new building he though was largely due to its own efforts and to the goodwill of Sir Thomas Wilford.

Growth of Upper Hutt - The advertisement in I his issue of the Leader for a cadet for the Justice Department is a still further indication of the recent growth of Upper Hutt and the results of that growth. There has been a Magistrate's Court at Upper Hutt since 1894. Up to 1930 the Courthouse was behind the Post Office building on the corner of Station Street the old Courthouse was formerly the old Post Office. The new Courthouse was erected on its present site in 1930. What a wealth of local history must have been revealed or made in the old building. What far reaching changes it must have witnessed. Up to 1955 a succession of police officers tilled the position of Clerk of the Court or later Registrar of the Magistrate's Court and what a job they made of their dual roles. However the police work and the court work had both grown to the stage where a civilian Registrar was needed. With the court work still increasing and the Births, Deaths and Marriages registration and Electoral work taken over the present building is much too small and additions are now being planned but who in 1930 could have foreseen the growth of the 1950s. We take courts and their work so much for granted that it is useful sometimes to pause and consider just what courts mean to the community. One of the first things done when New Zealand became a British possession was to set up a judicial system and from New Zealand's earliest days there has always been a judiciary unfettered by political or administrative control in the exercise of its judicial duties. But if by some mischance there were no courts, how would the community enforce sanctions against offenders? What sanctions could the police How would penal institutions receive their prisoners? We could perhaps have the concentration camp and the secret police but would they be possible under our Parliamentary

system? The only answer to the absence of courts seems to be dictatorship. Indeed we are inclined to underestimate and undervalue the worth of the judiciary. The court staff is the right hand of the judges and magistrates and whoever is the youth selected for the staff of the Upper Hutt Court he will have the satisfaction of knowing that he is serving the community in a rewarding role. Youth of today have great opportunities. They start their working life at a time when slump, war and aftermath of war have successively robbed employing authorities of a continuous line of young staff. As a result today's youth will rise rapidly to top positions. They have great opportunities and grave responsibilities.

Upper Hutt Police Station (1st Police Station was in the blockhouse) (old Police Station 1878 to 1920) (new Station 1919 to unknown) (1949 Police Station was in the Court House).

This set of 1909-1975 records and correspondence is about the Upper Hutt Police Station. The old police station was built in 1878 and was vacated in 1920 then let to tenants from time to time. A new Station was built in 1919. I have only transcribed part of this large set of records.

Magistrates Court House - Upper Hutt District

The first Upper Hutt Court house was situated in the Blockhouse with access from Fortune Lane off the road now known as Ferguson Drive. The first Upper Hutt Clerk and Bailiff was Constable David Lyster.

New Zealand Times newspaper 13 September 1894

The first sitting of the Upper Hutt Magistrate's Court was held in the old Post Office yesterday, before Mr Martin SM and Messrs J Cudby and J Wilkins, J'sP. Mr Haselden, Under-Secretary for Justice also sat on the Bench. Mr Wilford on behalf of the residents in the district welcomed Mr Martin to the Upper Hutt. His Worship in reply said that he had no power to represent the Government but he knew of the Justice Department's wish to bring the Courts as near to the doors of the people as possible. The following cases were dealt with Ernest Urwin charged with firing a gun in a public place was ordered to pay the costs and witness expenses. Thomas Phillips charged with using insulting and provoking language towards Henry Smith (for whom Mr Wilford appeared) was convicted and committed to St. Mary's Industrial School Nelson. Frank McCurdy for ill-treating a horse at the Upper Hutt was fined 40s and costs. Judgment was given for the plaintiffs in the following civil cases - E Wilkie v Manthall £3 12s 7d costs 14s - E Butler v Thompson £1 12s 5d, costs 16s. Mr Wilford appeared for the plaintiffs.

The next Court House was situated on the corner of Main Street and Station Street but was moved down into Station Street and a Post Office was built on the site on the corner of Main Street and Station Street which was renamed Geange Street..

The next Court house situated in Station Street (renamed Geange Street) behind the Post Office on the corner of Main Street and former Station Street (renamed Geange Street).

In 1930 another Court house situated in Main Street opposite Pine Avenue was opened on 13 August 1930. Around 1961 this courthouse was demolished and a temporary Courthouse was opened in the former Armidale Private Boarding house on Main Road (now Mall site) opposite St Hilda's Church (now McDonalds).

Old landmark to go

An advertisement in this issue draws attention to a further historical even indicating the growth of Upper Hutt and district. On Friday last when the Courthouse closed its doors to the public, it was more than the end of the day and of the week - it was the end of an era! The last business had been transacted in a building which had been a landmark in the community since it was opened in 1930. When this building was erected, it was expected that it would serve the district for many more year than has been so but for some years past the building has been too cramped and the quarters insufficient for the volume of business now required to be transacted there. There has been a Magistrates Court at Upper Hutt since 1894 And up to 1930 the then Courthouse behind the Post Office building on the corner of Station Street - the old Courthouse was former the old Post Office. It is now proposed to demolish the present Courthouse and on its site erect a new Courthouse, a public building of which the community may well be proud, suitable for the present-day requirements of the district and it is hoped for many more years to come. Pending the completion of the new Courthouse the Department of Justice has taken over the former Armidale Private Hotel building for use as a temporary Courthouse and the Registrar and staff of the Magistrates Court and all records have been transferred to that building. The first sitting of the Magistrate's Court in its new location was a special fixture held by Mr J R Drummond SM on Tuesday 02nd May while the normal fortnightly sitting was held on Wednesday.

A new Courthouse was built on the site of the former courthouse on Main Street opposite Pine Avenue and opened on 11 December 1962. The courthouse was built by Strickland and Pawson Ltd the company contracted on 18 August 1961 at a price of £33,892 The Courthouse was closed on 03 October 2012. This was due to the 22 February 2011 Christchurch Earthquake as there were concerns about its safety. On 14 November 2016 the building survived the Kaikora earthquake which affected many new building in Wellington.

The Upper Hutt Courthouse remains intact and in 2020 it was standing tall but still unoccupied.

Prison proclaimed - Liverpool Governor General – A Proclamation

Whereas by an Act of the General Assembly of New Zealand intituled the Prisons Act 1908 it is provided that the Governor General may be Proclamation published in the Gazette declare any house, building enclosed or placed to be a prison and from and after gazetting of any such Proclamation or from any time later specified in the Proclamation such house, building, enclosure or place shall be deemed a prison.

Now therefore I Arthur William de Brito Saville Earl of Liverpool the Governor General of the Dominion of New Zealand in pursuance if the above recited power and authority fo hereby declare that the area of land described in the Schedule hereto and all buildings and enclosures used or occupied thereon shall from and after the date of the publication of this Proclamation in the Gazette be a prison known as the Wi Tako Prison within the meaning and for the purposes of the Prisons

Schedule

All that piece of land in the Wellington Land District containing by admeasurement 362 acres 1 rood 27 perches more or less situated in Block I Rimutaka Survey District and being parts of sections numbered 96, 100, 104, 105, 106, 108 and 206 Upper Hutt Registration District. Bounded towards the north-west by the railway reserve and generally towards the east south and west by other parts of the aforesaid sections. As the said piece if land is more particularly delineated on a plan numbered 40/19 deposited in the office of the Chief Surveyor at Wellington and thereon edged purple.

Given under the hand of His Excellency the Right Honourable Arthur William de Brito Savile Early of Liverpool, Member if His Majesty's Most Honourable Privy Council, Knight Grand Cross of the Most Distinguished Order if Saint Michael and Saint George, Knight Grand Cross of the Most Excellency Order f the British Empire, Member of the Royal Victorian Order, Knight of Grace of the Order if Saint John of Jerusalem, Governor General and Commander in Chief in and over His Majesty's Dominion of New Zealand and its Dependencies and issued under the Seal f the said Dominion at the Government House at Wellington this fifth day of March in the year of our Lord one thousand nine hundred and nineteen.
